Federal law requires that we request and report the name, address, occupation and employer for any donor who contributes, in the aggregate, in excess of \$200 in any election cycle.

Federal law requires our committee to attribute a contribution to the individual who signs the check. If a contribution is being made by both spouses, each spouse should sign the check. In this case, the committee will attribute the contribution equally amongst each spouse. If a contribution is to be allocated to both spouses then each spouse should fill out a separate donor form. Federal PACs are limited to \$5,000 per federal election (primary and general are separate).

Contributions from the treasury funds of corporations and labor organizations, federal contractors (not including employees), and contributions from foreign nationals who are not permanent resident aliens are prohibited.
